2. Election of Chair

4. Chair's Report

The Chairman's report in respect of the last year was as follows:

"Firstly, I'd like to thank the team for all their hard work last year and for continuing to give up their time to support our community.

For the second year in a row, there has been a change to the team, Rebecca has left the role of TSPC Clerk and Stuart is welcomed on board and started in the role last month.

We continue to work with the borough council, suppliers and working groups to maintain and improve the Parish. This can be slow going but as individuals and as a group we keep pushing of improvements within the Parish.

Activities we have led, financed, help finance or been involved in over the last year have included:

- Community Litter Picks
- Funding of additional Road Sweeps

- Agreeing a new 3-year grass / hedge cutting contract with RMBC
- Pressing for timely repairs to roads and speed humps
- Supporting TIB where possible
- Funding for the summer parish party in the park
- Provision of Christmas Lights
- Installation of CCTV to four fixed locations
- Obtaining a grant from RMBC to help fund the CCTV installation
- Continuing to seek improvements in road safety
 - o Reinstatement of speed humps
 - o Seeking 20mph speed limit

Although Thorpe Salvin was not selected by the Borough for significant road safety improvements last year, TSPC will continue in collaboration with RMBC to push forward in obtaining road safety measures including the 20-mph speed limit. TSPC also looks forward to maintaining close connections with TIB to focus on improving the appearance of the Parish.

I look forward to working with you all over the next year to continue the work already initiated and start new projects to further improve our community with the help of our Borough Councillors."
